EXPRESSION OF INTEREST (EOI) FOR PROVISION OF WORK INJURY BENEFITS ACT (WIBA) INSURANCE COVER FOR STAFF

Background

The Free Pentecostal Fellowship in Kenya (FPFK) is an evangelical church registered in Kenya. It operates in 38 regions and has over 3,700 churches, with a combined membership of more than 500,000 people. FPFK was established in 1955 from a fellowship of Norwegian and Swedish missionaries who had been involved in mission work in Kenya since the 1950s and 1960s.

Our vision is to be a strong Pentecostal church that meets the needs of society holistically. To achieve this vision, FPFK has a Social Ministry Department that implements both development and humanitarian projects dedicated to meeting the spiritual, economic, and social needs of people through education, training, and socio-economic activities based on Christian values.

In line with this vision, FPFK invites Expressions of Interest (EOI) from eligible and reputable insurance service providers for the provision of Work Injury Benefits Act (WIBA) Insurance Cover for its employees.

Scope of Cover

The insurance cover will apply to all FPFK employees located across various regions in Kenya.

Services Required

The WIBA cover should provide benefits in accordance with the Work Injury Benefits Act, including but not limited to:

- 1) Occupational injuries sustained in the course of employment
- 2) Occupational diseases arising from employment
- 3) Medical expenses resulting from work-related injuries
- 4) Temporary total disability benefits
- 5) Permanent disability benefits
- 6) Death benefits payable to dependants in the event of a work-related fatality

Requirements

Interested insurance providers are requested to submit the following:

- 1) Company profile and statutory registration documents
- 2) Valid Insurance Regulatory Authority (IRA) license
- 3) Evidence of experience in providing WIBA insurance services
- 4) List of at least three (3) corporate clients served in the last three years
- 5) Proof of financial capacity and stability
- 6) Details of claims management and settlement procedures
